

Rental Application

We are pledged to the letter and spirit of the U.S. policy for the achievement of Equal Housing Opportunity throughout the Nation. We encourage and support a program in which there are no barriers to obtaining housing because of race, color, religion, sex, handicap, familial status, or national origin. All applicants must see the interior of the property before a lease can be submitted. Under extenuating circumstances an application may be accepted by viewing photos of the property or having a trusted acquaintance view for them. It is understood and agreed that all properties are rented in "AS IS" condition.

CRITERIA AND PROCEDURES

- 1) Application must be completed entirely
- 2) Application fee is \$50.00 per adult. Each adult must complete the application process and sign the rental lease agreement as a reasonable party.
- 3) Valid current photo documentation is required with each application (driver's license, military ID, Florida ID).
- 4) Your credit history will be checked using Beacon score from Equifax credit reports. A criminal background check will be processed. If you have ever been evicted, pleaded no contest to a felony, pleaded guilty to a felony, or been convicted of a felony within the last seven (7) years that is cause for denial.
- 5) Residency must be verified for twenty four (24) months. Rental history must be rated satisfactory or better.
- 6) Individual applicant must meet all requirements of criteria. If there is more than one (1) applicant, then at least one(1) of the applicants must individually meet one hundred percent (100%) of the requirements as listed below:
 - a) Gross monthly income must be three (3) times the monthly rent within \$100
 - b) Debt ratio may not exceed thirty five (35%)
 - c) Income may be verified by pay stubs, bank statement, or court statements. Persons using 1099 income must have two years of work history in the same or similar job in the local job market and furnish two (2) years of financial history. Co-signors are accepted at the manager's discretion only and must meet all requirements, and live in the state of Florida.
 - d) If you are moving from another state, your application fee may be increased.
- 7) If you have water-filled furniture, you must provide to Realty Select Services, LLC proof of insurance. (FS.83.535)
- 8) No properties are held for more than two (2) weeks unless approved by the owner.
- 9) Once the application is approved, you must provide a security deposit in certified funds and sign the lease within forty eight (48) hours.
- 10) If the applicant provides the security deposit and signs the lease then attempts to terminate the lease prior to occupying the property, the security deposit will be forfeited as liquidated damages for the owner.
- 11) Due to our fiduciary relationship with the owner, all applications will be processed and the strongest and highest rated application will be chosen for placement.
- 12) All information collected is considered confidential and for company use only.
- 13) Keys will be released on the first (1st) day of occupancy.
- 14) All funds prior to move-in must be paid in separate money orders and / or cashier's check. No cash accepted.
